ORDINANCE 210**

AN ORDINANCE OF THE CITY OF DALTON GARDENS, IDAHO AMENDING THE ANNUAL APPROPRIATIONS ORDINANCE NO. 209, THE ANNUAL APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2010 AND ENDING SEPTEMBER 30, 2011; TO REFLECT THE REVISED LID, ESTABLISHING THE REDUCED APPROPRIATION FOR EXPENDITURES FOR THE SEWERING PROJECT PER ORDINANCE 208; PROVIDING THAT THE TAX LEVY UPON TAXABLE PROPERTY WITHIN THE CITY IS NOT AFFECTED HEREBY; PROVIDING THAT ALL ORDINANCES IN CONFLICT HERewith ARE REPEALED TO THE EXTENT OF SUCH CONFLICT; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF DALTON GARDENS, KOOTENAI COUNTY, IDAHO:

Section 1: That the sum of \$1,291,454.00 be, and the same is appropriated to defray the necessary expenses and liabilities of the City of Dalton Gardens, Kootenai County, Idaho for the fiscal year beginning October 1, 2010, thereby amending Ordinance 209.

Section 2: PURPOSE AND AMOUNTS OF APPROPRIATION. That the object and purpose for which such appropriations are made, and the amount of such appropriation is as follows after accounting for receipt of unscheduled revenues:




newspaper of general circulation in the City of Dalton Gardens, and the official newspaper of said City.

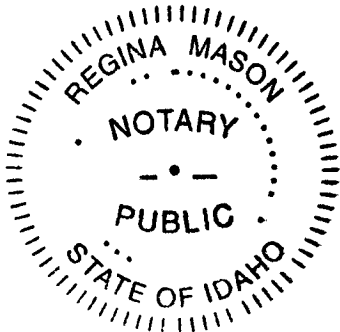
